# **Admission procedure**



The International students applications for next September intake are open from December to the end of June. An early application is advised since students are admitted on a rolling admissions basis. International students are admitted upon an online application form & a one-way-interview

#### Required documents

+

- Cover letter in French or English (depending on the language of the chosen programme)
- Photocopy of the last diploma obtained and/or a certificate of enrolment

- Results of an English test (depending on the programme) except if your mother tongue is English or if your previous

- Copy of a French test (depending on the programme) except if your mother tongue is French or if your previous studies

- Any other diplomas, certificates or useful documents

### Visa procedure

For French visa: non-European students need to apply to a VLS-TS. ICN Business School adheres to the CEF (Centre pour les Etudes en France) convention. Students who live in a country subject to the Etudes en France procedure must follow this procedure in order to obtain their visa. Students who do not live in one of these countries and need a visa to come study in France must contact the French consular authorities in their home country.

For German visa: All non-EU students have to apply for the appropriate German study visa at the German Embassy or Consulate responsible for their place of residence, no later than 3 months before their prospective arrival date. # **Tuitions fees**



If your application is accepted, your admission will only be confirmed once you have paid the deposit of €4,000 (non-refundable, except in case of not obtaining the visa or the previous degree). This deposit confirms the candidate's motivation to join ICN Business School and gives a fair treatment to all students who are eligible for our school but who are refused due to the lack of available places.

After receiving this deposit, we will send you the official admission letter with which you can begin the visa application.

The remaining tuition fees can be paid in one or three instalments in **the following 3 months** after the beginning of the academic year.
